L. Discussion and possible action to get City Manager to get 3 quotes on demolition of Community Center Project:

Hugo: Mayor, we decided to have a special board meeting today, because of course we all know about the project for the community center. I am asking for permission to allow me to get three quotes for the demolition of the parking lot. This project is not complete, the part of the parking lot is not a part of the overall Project, But it's a very important part of the overall project because its going to be what the people see off of 107. So, this is to demo approximately 9,700 square feet. And I'm asking for permission to go out there, its going to be less than 50,000. If I can get the three quotes, I believe that we do have the funding so that we can go out there. Quotes right now are ranging anywhere from 30-5-,000. Mayor: and these funds are coming from the money that we secured from state? Hugo: No, this is going to be from general funds. Flores: So, you can't use the park money for that? **Hugo:** I can use the park money as long as I put it back. Now, what part of this particular project is going to be the fees for the engineer. Mayor: I would assume anything associated with that project, we can tie it back to **Hugo:** we can tie it back, but I didn't want to take anymore funding from that particular project, to kind of concentrate on the community center and the park. One thing I forgot to tell you all is that the parking lot is going to be done by precinct one. So, precinct one will be doing the actual work, but we are going to have to purchase the materials. Mayor: Are we going to do a MOU? Hugo: They are going to set up a MOU, we are going to check to see if we can use existing MOU, or if we are going to need a new one. They are telling me that they have a new council for the county now so, it's a lot easier than before. One of the things that they mentioned, was that they are going to get the material and we are going to pay them. So, we are going to get the material at their cost. It's a small parking lot, I don't think it'll be more than \$10,000. Mayor: So, 10 plus 50. Hugo: Well I'm not trying to go with the 50. Anything over 50, we have to go out for bids. Just so you know the process, anything over 50,000 we have to go out and post it and do that whole thing. Anything less than 25,000 I can do it here. But anything over 25,000 I do have to talk to the commission. Mayor: So, obviously when you get the quotes, we are going to be looking at price and the amount of time these people are going to take to mobilize and demolish the area. Hugo: I'm

going to be taking a look at all those aspects and make sure they are bonded and all that good stuff. It's not just going to be a throw away project. But at the same time if I can find something less than 25,000, I'm going to take it. Right now, we got about 4 quotes, they are over 30. But I think we are going to be okay. Mayor: Can you guys do some homework, make sure that there is no surprises there. We don't want to find an old gas. Flores: Didn't we already look into that? There shouldn't be anything. And even if there is as long as its parking lot it shouldn't effect that. Because there's not going to be an actual building on top. Cabrera: For them to take the debris also. **Hugo:** what I am asking for is for you to get the 3 quotes that I need, I'm going to go with the lowest bid. And based off the lowest bid will be, taking care of the debris, and clean up everything. So, it's going to be left plain. What I'm trying to do here is ask for permission. If in case I cant find anything less than 25. Flores: I don't want it to come out of general funds. Mayor: Right, its part of the package, the community center. Flores: Maybe if we can get it from the park, and then towards the end if we are seeing that funds the parks is going to sort of come to an end and we have to pay it back from the city then I understand. But if we can start it from there. **Hugo:** The way I'm going to be moving the money, and just this, and the reason being like I said. I don't want from the integrity from that particular project. The reason this went as a separate project is of precinct 1 helping us out. We are going to be saving quite of bit of money with precinct 1 doing it. If we have to put in some money, we are looking at 30,000 or whatever. The money is there, we can figure it out. We are not going to be using, for instance I have on the budget I have about 15,000 on pool maintenance. Which we are not going to be using this. So those monies I will be moving over. Mayor: maybe we can start setting up a workshop so we can figure out our budget, so I can see what areas we can amend. The thing that we were never able to do was prioritize the areas that we need, such as this construction. So, we need to come up with a plan to help the budget and amend the budget as needed. Hugo: Once we get to that point, I would say maybe we can so a workshop so we can set up, and we can talk about prioritizing different things. Mayor: That might include the funding, Hugo: a good example might be the entrance. Because people are saying, oh we are going to get a new community center but look at the entrance of the city. So, this is an accident waiting to happen. So those are the areas I want to concentrate on and see if we can move some money. But if we do a workshop, maybe along with the ordinances. Flores: When are we going to have the workshop? Mayor: As soon as possible. Because we need to start looking at money for items such as this. Ok. So, I'll need a motion to allow city manager to get 3 quotes on the demolition on the community center project. Motion by commissioner Chapa, second by commissioner Flores.

There is measuring system that the storm water system has, and what they do is place a radar and put it on different, like a river or a casaca or something and it measures the water. What they are wanting to do is to combine all three cities. It's nothing that's happening right now but they just want to have a MOA in order. They are doing the same thing with Elsa and the same thing with La Villa. **Mayor:** What are they going to charge us to be part of this. **Hugo:** I believe there was about 50,000 dollars that they wanted to spend. It's not in here but its going to be broken down between the cities. But like I said this is just preliminary, they want to have everything in order. Then they will come in and present, whether we want to move forward at that point in time we can. **Mayor:** But we are guaranteed some sort of service,
