R. **Public Comments Mr Hernandez:** Mayor we do have 2 individuals that signed up today first of all we have Noah Lara

Noah Lara: The reason I am here is to convert C V Mendez street into Polo Lara street. Just briefly I wanted to introduce my dad. He has passed away at the age of 91. He resided here since the 1930's. He assisted the city government here, especially the Mayor John Schmalzried. When Schmalzried was here and Edcouch was growing with a lot of business. I will give you an example. Back then they only had one officer on patrol, as you all know Edcouch used to be filled with Cantinas, my dad was well known and my brother Ruben was working as a police officer, when they made an arrest they had to take the prisoner to the county jail, which was several miles away, so the city was left by itself with no protection. Since a lot of people knew my dad, so when my brother took the prisoner to county my dad would step in. If there was fights my dad would settle it. Aside from that when they had the canal right beside the railroad track, they did carry water. Victoria street was caliche and a lot of people that would go to the market would drive through there fast. A lot of the caliche dust would settle into the trees and into the vehicles. So my dad petitioned it to get paved. During that time my dad came up with an idea to make it look like the best looking street and to put palm trees. My dad also got rid of the rattlesnakes here in Edcouch, and he was a participant of the city. He believed in the city. His cousin was Apolenio Gutierrez. So I had requested with the old administration that left to put it under his name, so I am asking the new council to take it into consideration. I have got the signatures and everything. If it could get to a point when you google it, it can show up. I m hoping and praying to change it to Polo Lara Dr. Mayor: Ok, thank you we will look at the Procedures.

Mr. Hernandez: Mayor we also have Mr. Hugo Dr La Cruz from the City of Edcouch. Hugo: Mayor I would like to take this opportunity of all the things have been happening, I need to let you know a few things, One, Urban County Conference has been postponed till August. What I did want to talk about briefly, In lieu of everything that is going on right now, the Mayor, myself and Manny, got together with local citizens. We also met with a citizen from Edcouch who is a retired Lt. Col., he came in a brought us a lot of good information, as a matter fact his expertise is in emergency management. As a matter fact Manny, myself and the Mayor have a lot of things going on. So one good thing is to involve the community. So after researching and brain storming we came up that as neighbors we have to take care of each other. So one thing we came up with was, a thing called Rogers Neighborhood Taskforce. Named after Mr. Rogers from Mr. Rogers Neighborhood. Rogers Neighborhood will be a taskforce made up of citizens. I think its important to let you all know that you all know people. So you can notify them to start getting involved. Just to start off the Mayor already nominated your wives, as the first group of the taskforce. The idea is to have people within the community to take action. This is something that will not only be used for the current situation, so if you all have any questions, let me know. Mayor: We think this is a good opportunity, to keep an eye out for each other and can also work as a neighborhood crime watch system. By tomorrow morning I want to be able to identify a person from each street to move forward. We will take it from there. Chief Q: Mayor if there is any guidance that the police dept can provide, we will take it from there. Mayor: Definitely, you are always a big component of all of this, of anything that we do of this magnitude, you and the fire dept are always a critical part of this.

T. Presentation by Hollis Rutledge and Associates on there City Quarterly Report

Frank San Martin: Good Evening Mayor and City Commissioners, Frank San Martin with Hollis Rutledge and Associates, we have been working on several projects. The Library grant was awarded 2 or 3 weeks ago, it was 400,000 that will help create the first library here in Edcouch. You guys also got 1,000,000 dollars from Texas Parks and Wildlife, we helped get everything in order to get that money, and I know now you guys are working with engineers to get it going. With the Police Dept, we have been working on several grants that were submitted, some were renewals, we got those submitted in time. We also applied for Border Star, Stone Garden, Niebers, and Rifle Resistance and Body Armour. We are expecting to hear something back probably to late summer just because of the COVID 19 virus. At the same time we are working through a USDA grant to maybe get the fire dept some equipment, it's a smaller grant of about 50,000 dollars but we are in the process of just getting all the paperwork in. And then we are also working on a Valley Baptist foundation grant. To get some funding for the library and the pool. So these are some things that we are working on to secure some funding. We are waiting to hear back, and we are still applying for more funding. I know Manny calls me like everyday, but we also provide any management assistance with grants. So we are happy to be working with you guys. Do you guys have any questions for us? Mayor: I know we have been getting grant applications from Congressman Gonzalez, please make sure that you guys are looking into those. Thank you. Manny: We have been looking into all our options, and anything we can get ahold of, rest assure we will work diligently to make it happen. Hugo One thing I want to add, we are currently working on a a Municpal Garden, we went ahead and started, because I know that a lot of these grants, they have time limits. But they did mention to me that we can still apply for the Garden Grants. One of the ones that we wanted to look into was the Monarch Butterfly grant. Which will allow us to put a flower bed. **Frank:** Yes just let us know.

Our team is happy to be working with you all. I am excited on what is going on here. I know that in the next 3 to 6 months there is going to be big things happening.

U. Discussion and possible action to approve fees for towing and auto recovery from Almaraz Towing and Auto Recovery pursuant to state Law

Manny: Good Evening Mayor and City Council members. These are the fees that Almaraz charges in general whether it be for DWI, Car Accidents, etc. These are fees that are reported to the state and need to be approved by the state in order for them to be able to work. They operate with a license, so one of the requirement is that they present these fees to you guys, you guys look at it and you guys know what they are charging. So in you packet there is a list, also there is a list of departments that Almaraz towing and recovery works for, and as you can see there is quite a bit of them. This is for review and that you guys take action and for possible approval. **OJ:** I have looked at these fees and they seem to be in order with other recovery bodies

V. Discussion and possible action to allow Strada Engineering to apply for grants pertaining to Hazard Mitigation

Manny: Mayor and City Council Members, again this was, Strada Engineering, Oscar Cancino, approached me a few weeks ago, and he did say that there is some money available to the Delta area that we have not recovered, there is money available for us that we did not even know about. This money is for Hazard Mitigation, to put retainage ponds, it has to do with flooding, to get the water out of here faster. There is no charge involved, basically he is telling us that if he gets us the money, he is going to get paid a percentage of the consulting fee. If he does not get us anything the city does not lose. We are not obligated to anything. All we are doing is that we are giving him permission to apply for a grant on behalf of the city. So it's a win win situation for the city. We are not hiring him as a consultant, we are not hiring him as an engineer. We are just hiring him to get the city some appropriate funds. Mayor: So this motion will also consist of legal review? Manny: What happens is that they only have till March 30, to get this approved. Hugo: I prefer if there is a way to proceed pending legal. OJ: No, I don't think that there is any question in my mind, without having anything in writing to determine the percentage and amount, it is very hard to go all in, something that we don't know about. I would imaging that if they have done this in the past, they can just email me or the city manager tomorrow.

W. Discussion and possible action to approve Ranking and Begin Negotiations on Contractor for Community Center Project

Hugo: Mayor I would like to bring in Mr. Eli Alvarado and Mr. Eddie Saenz. Mr Saenz will start off. **Edddie:** Mayor and City Council, bids were taken on Monday for the Community Center and we met yesterday and ranked them. The rankings for the 8 quotes I received are higher than the budged amount. They are competitive sealed proposals, and we are recommending and as you can

see here, and as you can see here in the spreadsheet we had 4 evaluators and 8 proposals. They range from 834,000 to 1.3 million. We ranked them and we used the ranking criteria of experience, performance, financial stability as well as the price. And within this ranking we had individual rankings and we came up with the highest rank, and the Contractor to be Trigen, event though he was third on the list in regards to price, we felt he was the most qualified, and then we go to number 2 which was ranked at 349, who is Arrell, now Arrell we are going to recommend that they be disqualified because they did not acknowledge one addendum, and we also felt that 90 days is to little time to complete. We have to decide what route we want to take to negotiate if we select the order. Eli Alvarado: Good evening Mayor and City Commissioners, Vice President of Alvarado Architects and Associates, Mr. Saenz commented, that we did rank the general contractors in the list you have before you. Where our goal is to go down the list and try to see how close we can get back to our original budget, the process is always to go with the highest rank general contractor if we cannot come to an agreement then we go to the second rank, and we go down the list and at that point if we do not think that we can get to where we are at, we would go out to you and say we would have to reject the bids, and go out and rebid and do what we have to do, and that means coming back, and putting out to bid again. We don't anticipate spending to much time on the negotiations that way we know what we have to do we don't want to go over 30 days obviously. Another part is that the pool has already been advertised to go out for bids, we will be accepting proposals on April 2, and at that time we know what that cost will be. Hugo: Mayor I I would like to also point out that from the library project, it will be within the community center, so some of the money that was brought in, can be used for the community center. Mayor: So for now you want us to approve the rankings? Eli: Yes Eddie: Mayor I just recommend to negotiate with the top 2.

So we don't have to come back to a special meeting as long as its consistent as to what the state is going to do.
