U. Discussion and Possible Action to Approve CSJ Group to Proceed with lift stations at Villa Estates and Ariana Estates Pending Cost Estimate

Mr. De L a Cruz: Yes mayor, I'd like to recommend that you all approve this item here. These are the lift stations that we are looking at with the developments that are coming up on St Mary's and over on Mile 17 Ariana. These items, or the lift station is part of the negotiation. Now the reason that it is pending is because we want to get contracts approved before we move forward. Is that correct council?

OJ: That is correct.

Commissioner Cabrera: Who are the contractors?

Mr. De La Cruz: The contractors they are Mr Villarreal from the Villarreal Brothers out of Mission and Mr. Vela out of Mission also.

Commissioner Cabrera: Yeh, but what is the company's name?

Mr. De La Cruz: What do mean what is the company's name? It is their property.

Commissioner Cabrera: What is the contractors name?

Mr. De La Cruz: That is their property. The property over on 17 belongs to the Villarreal Brothers.

Commissioner Cabrera: Ok

A motion to approve CSJ Group to Proceed with lift station at Villa Estates and Arianna Estates Pending Cost Estimate. A motion was made by Alderman <u>Segura</u>, 2nd by Alderman Flores. 3 voted Aye 1 vote apposed Motion Carried.

Mayor: For the record Mr Cabrera is opposing the item.

Mr. De La Cruz: Mayor, before you proceed just for the record these two developments that are coming up. The developments are going to benefit the city with over \$130,000 in taxes as well as water accounts for the city. So just so you know, I wanted to bring this up because a lift station at both of these locations are going to cost u s about \$120,000. We are going to make that back within one year of the building of the last home. This is going to bring more roofs to the city and I think the City of Edcouch has been left behind long enough when it comes to development and I commend Mr Flores, Mr. Segura, and Gutierrez for approving this item because this is giving the city breathing room when it comes to taxes. Thank you.

Mayor: We agree that has been our goal, for the city to grow and a development is the first step.

V. Discussion and Possible Action to Approve Ordinance 2021-16. Mr. De La Cruz: Mayor, before I recommend this item to be approved. I would like to say that this is something that is going to be extremely beneficial for the city. Again, I commend Mr. Flores Segura and Gutierrez because they have gotten us to this point to be able to renew this. This is an issue that has been hurting the city that was brought by prior administrations and it really hurts the city because our debt service really does not let us grow. It is really hard for us to be able to take care of these bonds. And for us to be able to take care of these bonds you need the money. We have one particular bond that comes in June and it is over \$150,000 and its growing. Every year it grows, every year it grows more and more and because it does that every year it puts a bind on the city. So, at this time and before I recommend approval I would like to give the floor to Mr. David Gonzalez. I am going to share his documentation so that you all can follow along with him.

David Gonzalez: Good afternoon mayor and council, for the record my name is David Gonzalez V. As Hugo just mentioned I have a presentation. I visited with some of the council and some of the administration over the last couple of months and I became aware that this 2012 allocation for the city was really putting the city in a tough financial position. It was my understanding that this 2012 bond issue was really choking the city and basically every time the money that you all were able to generate throughout the year you would have to make these large bond payments. So, what we did was spoke to the NADB Bank, which is the North American Development Bank, who does these kinds of long-term loans. As Hugo mentioned, you know this is a Limited Tax Refunding Bond, but this isn't the traditional refunding for savings, this is a restructuring of existing debt. So, you are not saving money the way other refunding's you would save money. Here, it is like if you have a ten-year mortgage, and you are refinancing it to a thirty-year mortgage. So, over the life of the loan, you are going to end up paying more interest but your monthly or your yearly bond payment is going to reduce significantly so what we are actually looking here is instead of paying about 150,000 a year for the next ten years you are going to pay about 45,000 a year but now you have an additional twenty years added to the loan. So, if you look at page number three of this document, and I don't know if Hugo can, go to page number three Hugo please. I'm sorry page number four. So, if you look at the second column from the left you have prior debt service that is your current obligation right now. The city has to make these bond payments every year. So next year you are going to have to pay 139,349.50 by refinancing everything your new debt service will be one column over to the right under refunding debt service. So instead of paying o139 you are paying 35,000. Next year in 2023, instead of paying 140,356 you are paying 45,000 and so on and so forth. So, if you go down to the bottom, it totals it out. You are paying additional interest because you are stretching out the loan twenty years because you are getting that breathing room on an annual basis for the next ten years and you are not having to turn over all the cash flow that you all generate to make this one bond payment from 2012 because that 2012 Obligation was a variable loan. Every year that rate and that amount keeps growing and growing. So, that is the information that we have for you all and I said this is restructuring of your debt, it is not a refunding for saving and I am happy to answer any questions on council and on the report that is also here, but we are having to answer any questions that you all may have on this loan.

Commissioner Flores: This is Commissioner Flores, where is this debt coming from? What is this loan structure from? What is it? What projects or what are they from?

David Gonzalez: So, I wasn't the FA, but this is a 2012 Certificate of Obligation. I am not exactly sure. So, in 2012 I don't know what these bonds were used for I think Hugo was in charge of it but

based on the bond council and some reports it is showing that the bonds were used for water and sewer system improvements, trucks for the city.

Commissioner Flores: Well, the important thing was that it was in 2012 so it was way before our time. So it throws it back on the previous administration that was there before us, right?

Mr. De La Cruz: You are right Mr. Flores, I believe this was an old bond that was refinanced, and it was brought back up water and sewer. I believe these bonds were used for some infrastructure. Some of it was used for water meters and that project in particular.

Commissioner Flores: May I ask who was the mayor in 2012?

Mr. De La Cruz: I can answer these questions Mr. Flores because I did my research on it and the mayor was Robert Schmalzried.

Mayor: Mr. Gonzalez, this is the mayor, I have a couple of quick questions.

David Gonzalez: Yes mayor

Mayor: Ok, so by restructuring this loan, this bond payment again is there any negative consequences to the city as far as audit purposes or credit ratings?

David Gonzalez: No sir, you don't have to worry about that right now. The city does not have a bond reading and what you would be doing by refunding these bonds is you would be basically having an escrow handle the old bonds and you would only be responsible for this. So it wouldn't negatively impact the city in any way as far as any kinds of rules or regulations as far as reporting or material amends or those sorts of things. The only difference is by restructuring you would be paying more interest over thirty years, but you are achieving what you wanted to achieve which is getting some breathing room over the next ten years. That is what this does for you.

Mayor: Correct, and that has been our goal.

Mr. De La Cruz: Mayor, I recommend that you approve this item and that we move forward with Mr Gonzalez., PFM, Mr. Dan Martinez, bond council so that we can proceed with the restructuring of our bond.
