Mr Rosales: Mayor, I am going to go ahead and hand this over to council.

OJ Jimenez: What item is this? Im sorry I don't have a copy od the agenda

Mr Rosales: Possible Action on the City Ordinance for Parades

OJ Jimenez: Ok, Mayor, city council good afternoon. After further review and analysis on this particular ordinance what we went ahead and did, apparently TxDot is requiring an application coupled with a resolution so that way the parade on December 11th can go forward. So we did provide to the city a resolution to that effect and the resolution has been preliminary approved by the TXDot legal department regarding that. At this time mayor, it is not going to be an ordinance, it is going to be an adoption of the resolution allowing the closure of State Hwy 107 as outlined in the resolution and then what we are going to do in turn, once that is accepted today, om Monday we will submit the application with this particular resolution. So it is our recommendation that this resolution is adopted and accepted.

A motion to Approve City Ordinance on Parades was made by Alderman <u>Gutierrez</u>, a second motion was made by Alderman <u>Segura</u>. All in favor signify by saying Aye. Opposed. Matione Carried.

T. Discussion and Possible Action on Contract with North Alamo Water for New Development on Mile 17 ½ and Mile 4, Rancho Nuevo Estate Subdivision.

Mr Rosales: Mayor, we ask at this point for a recommendation from our engineer. What we want to make sure is that by us getting into this agreement that we are not basically giving up our right for annexation. I do believe that we discussed this in the past with our engineer and it was his recommendation a that time that we annex Mile 4 all the way to Monte Cristo. So when in fact the developer was to bring plans for approval for us, we could ask for voluntary annexation of that property at that time. So basically id like to ask our engineer if by getting into this agreement if we are not giving up that right?

Eddie Saenz: You shouldn't be giving up that right. And basically and OJ can step in here, your attorney, the way I understand it is the agreement between North Alamo Water Supply and the city. Well the city can get into agreement only if it's in its city limits and under their jurisdiction. So we need to get that voluntarily annexed first during the development process. So I think you can make it subject to that happening and then we could probably pass it on back to the attorney at North Alamo Water.

Mayor: So right now you're recommendation is?

Eddie Saenz: It is to allow the process to happen in regards to annexing Mile 4. So we can be connected to the potential development. The development has to be submitted anyway officially first to the city before you can even act on it and then act on this. Because now you have jurisdiction over the property of the development.

Mr Rosales: So your recommendation would be to table this item?

Eddie Saenz: Yes, to table the item and talk to the developer and see their development but also at the same time start the process of putting together the survey and the needs of annexing Mile 4 all the way north to Monte Cristo.
